**MASSACHUSETTS DEPARTMENT OF REVENUE**  
**WEEKLY INCOME TAX WITHHOLDING TABLE, EFFECTIVE JANUARY 1, 2015**

How to use the **WEEKLY** wage-bracket table method of Massachusetts income tax withholding:

1. A claimed spouse counts as "4" exemptions for Massachusetts income tax withholding purposes.
2. If employee is head of household, withhold \$2.38 less than the amount shown in the tax column.
3. If employee (and/or spouse) is blind, withhold \$2.18 less than amount shown in the tax column for each such person.
4. If employee has exemptions or wages not covered by the table, use the percentage method on page 12.
5. If employee claims that he/she is a full-time student whose annual income will not exceed \$8,000, do not withhold Mass. income tax.
6. If employee claims that he/she is exempt under MSRRRA and has filed Form M-4-MS, do not withhold Massachusetts income tax.

## BIWEEKLY INCOME TAX WITHHOLDING TABLE, EFFECTIVE JANUARY 1, 2015

How to use the **BIWEEKLY** wage-bracket table method of Massachusetts income tax withholding:

1. A claimed spouse counts as "4" exemptions for Massachusetts income tax withholding purposes.
2. If employee is head of household, withhold \$4.75 less than the amount shown in the tax column.
3. If employee (and/or spouse) is blind, withhold \$4.36 less than amount shown in the tax column for each such person.
4. If employee has exemptions or wages not covered by the table, use the percentage method on page 12.
5. If employee claims that he/she is a full-time student whose annual income will not exceed \$8,000, do not withhold Mass. income tax.
6. If employee claims that he/she is exempt under MSRRRA and has filed Form M-4-MS, do not withhold Massachusetts income tax.

How to use the **SEMIMONTHLY** wage-bracket table method of Massachusetts income tax withholding:

1. A claimed spouse counts as "4" exemptions for Massachusetts income tax withholding purposes.
2. If employee is head of household, withhold \$5.15 less than the amount shown in the tax column.
3. If employee (and/or spouse) is blind, withhold \$4.72 less than amount shown in the tax column for each such person.
4. If employee has exemptions or wages not covered by the table, use the percentage method on page 12.
5. If employee claims that he/she is a full-time student whose annual income will not exceed \$8,000, do not withhold Mass. income tax.
6. If employee claims that he/she is exempt under MSRRRA and has filed Form M-4-MS, do not withhold Massachusetts income tax.

6. If employee claims that he/she is exempt under MSRRRA and has filed Form M-4-MS, do not withhold Massachusetts income tax.

6. If employee claims that he/she is exempt under MSRRA and has filed Form M-4-MS, do not withhold Massachusetts income tax.

# Massachusetts Income Tax Withholding System Percentage Methods for Wages Paid from January 1, 2015

**From employee's total wages:**

1. Subtract the amount deducted for the U.S. Social Security (FICA), Medicare, Massachusetts, United States or Railroad Retirement systems. The total amount subtracted may not exceed \$2,000. When, during the year, the total amount subtracted reaches the equivalent of the **\$2,000 maximum** allowable as a deduction by Massachusetts, **discontinue** this step.
2. Subtract the total of the exemption factors, i.e., the dollar value of the employee's exemptions, for the applicable payroll period. If an employee claims "0" exemptions, **discontinue** this step.
3. After subtracting the amounts specified in steps 1 and 2 above from the employee's total wages, **multiply** the result by **.0515** and withhold the resulting amount.
4. If the employee will file as head of household on their tax return, either (a) **add** to the amount computed in step 2 and subtract the total from the wages: weekly: \$46; biweekly: \$92; semimonthly: \$100; monthly: \$200; daily: \$7; annually: \$2,400;

**or (b) subtract** the head of household tax value from the step 3 result: weekly: \$2.38; biweekly: \$4.75; semimonthly: \$5.15; monthly: \$10.30; daily: \$0.34; annually: \$123.60.

5. If the employee and/or his/her spouse is blind: either (a) **add** the blind exemption factor to the other exemption factors in steps 2 and 4(a), if applicable, before subtracting the total from the wages: weekly: \$42; biweekly: \$85; semimonthly: \$92; monthly: \$183; daily: \$6; annually: \$2,200;

**or (b) subtract** the blindness tax value amount from the result from steps 3 and 4(b), if applicable: weekly: \$2.18; biweekly: \$4.36; semimonthly: \$4.72; monthly: \$9.44; daily: \$0.31; annually: \$113.30.

**Important Note:**

**Do not withhold** from employees who claim one or more exemptions if their wages are less than: weekly: \$154; biweekly: \$308; semimonthly: \$333; monthly: \$667; daily: \$22; or annually: \$8,000.

# Massachusetts Income Tax Withholding System Percentage Methods for Pension, Annuity, Other Periodic Payments and Nonperiodic Payments (e.g., Lump-Sum Distributions)

Paid January 1, 2015 and thereafter

## A. General Information

Payers and plan administrators of pension, annuity, other periodic payments and nonperiodic payments made to recipients with Massachusetts addresses who have not elected to be exempt from the U.S. income tax withholding provisions must withhold Massachusetts income taxes, effective January 1, 1984. The Massachusetts withholding system differs from the U.S. system.

## B. Form M-4P

The Massachusetts Withholding Exemption Certificate, Form M-4P (or a reproduction or other payer-substitute form), should be made available to each recipient.

A recipient, whether receiving periodic or nonperiodic payments, may claim the applicable personal, age 65 or over and blind exemptions (for both spouses) and the exemptions for dependents. If a recipient does not file Form M-4P with the payer, Massachusetts withholding will be based on "0" exemptions. In such cases, 5.15% of each payment will be withheld from January 1 through December 31 of the calendar year.

Form M-4P may be used to request that an additional amount be withheld.

Form M-4P should also be used to claim exemption from Massachusetts income tax withholding by a recipient with a Massachusetts address but who is domiciled (legal resident) elsewhere and whose pension is from certain pension plans not subject to tax under Title 4 of the United States Code, section 114.

Recipients with other than Massachusetts addresses may request, by filing Form M-4P, withholding on payments taxable by Massachusetts.

## C. Figuring Withholding

The Massachusetts Income Tax Withholding System Percentage Methods for Pensions, etc., for computing amounts to withhold, appears in the next column. If a payment period differs from the four specified, adapt accordingly.

## D. Paying Over Amounts Withheld

The trustee or administrator of the pension or annuity plan must register with DOR online through WebFile for Business, using the plan's federal tax identification number and checking the appropriate box. Generally, a plan is required to obtain its own Federal Identification number. Returns are due annually, and payments are subject to the same schedule as withholding on wages with regard to frequency. Returns and payments must be made electronically.

## E. Reporting to Recipients

Provide a copy of U.S. Form 1099-R, showing the total payment and amount withheld for Massachusetts during the year, to each recipient by the end of the next January for the Massachusetts income tax return.

## F. Other

Massachusetts provisions for payer and authorized sender responsibilities and recordkeeping are the same as those for the U.S.

### From recipient's total payment:

**1. Subtract** the total of the exemption factors for the applicable period. If "0" exemptions claimed or no M-4P, omit this step.

**a. Monthly:** \$83 multiplied by number of exemptions claimed, plus \$284.

**b. Quarterly:** \$250 multiplied by number of exemptions claimed, plus \$850.

**c. Semiannually:** \$500 multiplied by number of exemptions claimed, plus \$1,700.

**d. Annually:** \$1,000 multiplied by number of exemptions claimed, plus \$3,400.

**2.** If the recipient will file as head of household on their tax return, **add** to the amount computed in step 1 and subtract the total from the payment: monthly: \$200; quarterly: \$600; semiannually: \$1,200; annually: \$2,400.

**3.** If the recipient and/or spouse is blind, for each blind person **add** to the amount computed in steps 1 and 2, if applicable, and subtract the total from the payment: monthly: \$183; quarterly: \$550; semiannually: \$1,100; annually: \$2,200.

**4.** After subtracting the amounts specified in steps 1, 2 and/or 3 from the recipient's total payment, **multiply** the result by **.0515** and withhold the resulting amount.

## Important Note

Payers are requested to urge recipients to ask that additional amounts be withheld on Form M-4P to cover taxes for certain payments taxable at the 12% rate or for other income not subject to the withholding system.
